D. 2016 Federal Income Tax Data Verification – Information to Be Verified (Student, parent, spouse, or partner - if applicable)

 - The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at www.fafsa.gov. In most cases, no further documentation is needed to verify 2016 income information that was transferred into the student's FAFSA using the IRS DRT.
 - o If IRS DRT is not used, a 2016 IRS Tax Transcript is required. It may be obtained through:
 - Online Request- Go to www.IRS.gov, under the Tools heading on the IRS homepage, click "Get Tax Transcript by Mail." Click "Get Transcript by Mail." Make sure to request the "IRS Tax Return Transcript" and NOT the "IRS Tax Account Transcript."
