

Instructions to enter your Social Security number in WaveNet

Please find instructions below to enter your Social Security Number (SSN) on the Applicant Center in [WaveNet](#). If your FAFSA is rejected for any reason please follow the instructions listed on your Student Aid Report (SAR) to make corrections. You may contact FAFSA at: Federal Student Aid Information Center at 1.800.433.3243.

If you did **not** provide your SSN on the Common Application, you may update it through WaveNet by logging-into your WaveNet account. Your WaveNet access credentials were provided in a prior email. You may contact the Pepperdine HELP desk (310) 506-HELP or (866) 767-8623 if you need assistance logging onto WaveNet.

Please make the SSN update as soon as possible but no later than **March 31, 2015**. Once we receive your updated information we will review the FAFSA for federal aid and institutional need-based aid. Please note: Your file was already reviewed for academic/merit aid.

Once your SSN is updated and processed you may qualify for federal and/or institutional need-based funding. **If you qualify you will be notified after the initial awards are processed but no later than mid-April.**


1. Log into your [WaveNet](#) account to update your SSN. You **cannot** correct your SSN in WaveNet you can only enter it if you did not provide it previously.
2. Once you login WaveNet follow the instructions/screens below.

4. When clicking the link, you will be taken to a new page where you enter and verify your SSN.

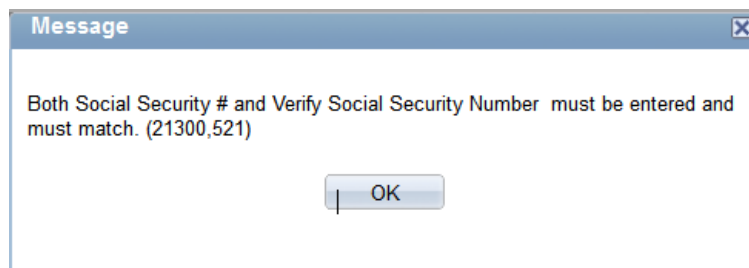

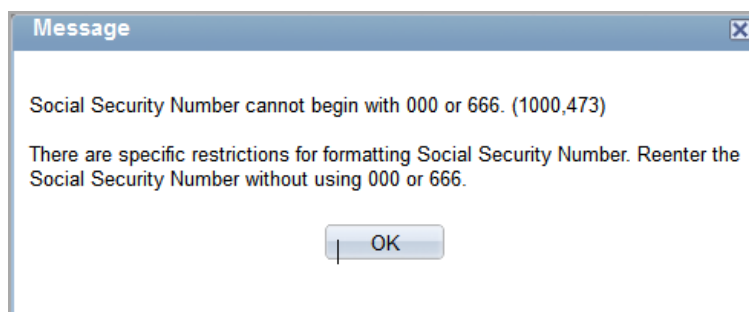
5. The values in the fields are checked and if they are considered valid, the SSN is updated. You will then be taken back to Applicant Center and the link disappears.

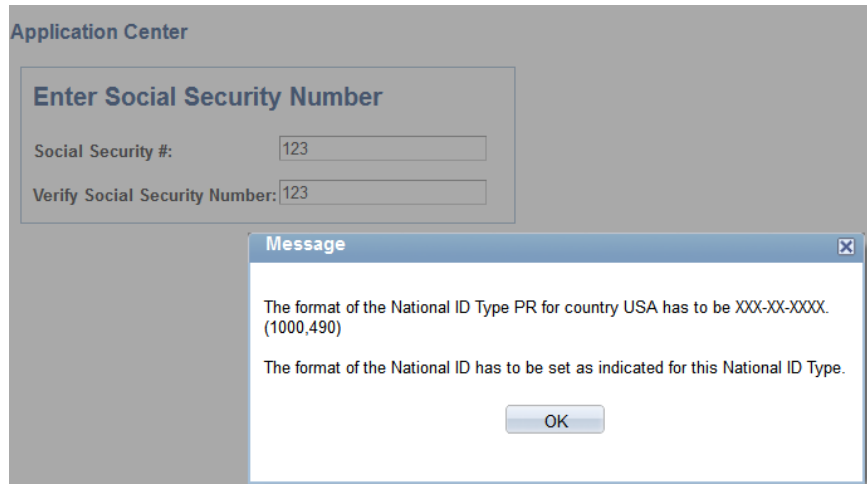
YOU WILL RECEIVE AN ERROR MESSAGE IF ANY OF THE FOLLOWING ISSUES EXIST:

- Either Social Security # or Verify Social Security Number is missing, or they differ.

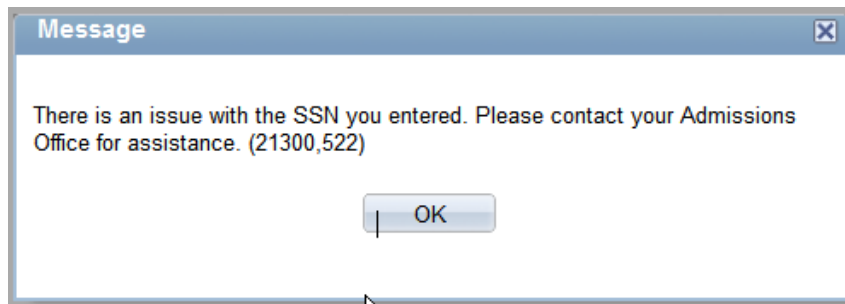


- The SSN does not comply with specific format rules, as enforced by HR.

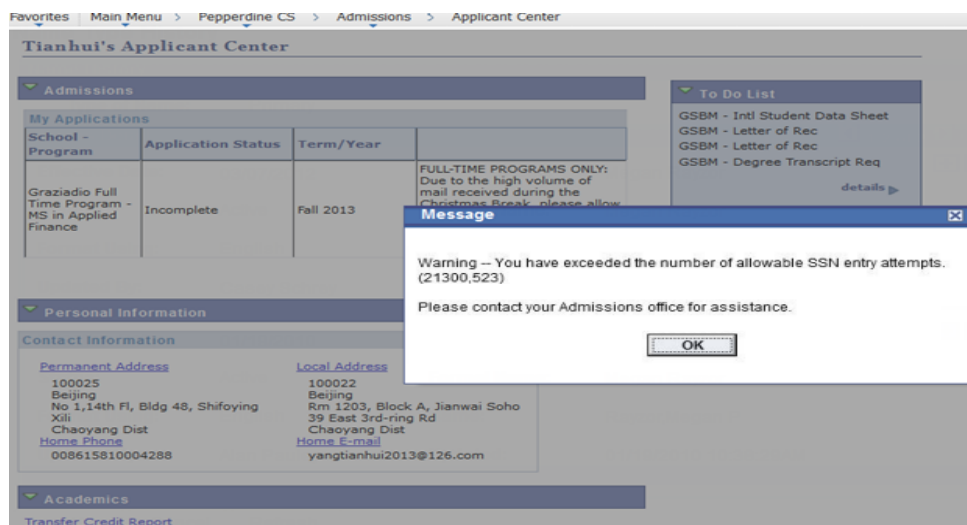




- If the SSN exists already on another person's record.



- If you have tried to enter somebody else's SSN 4 times, the following message shows. Also, the same message will show when you click the link. This number gets reset for every session (i.e. when you log out and then log back in).
